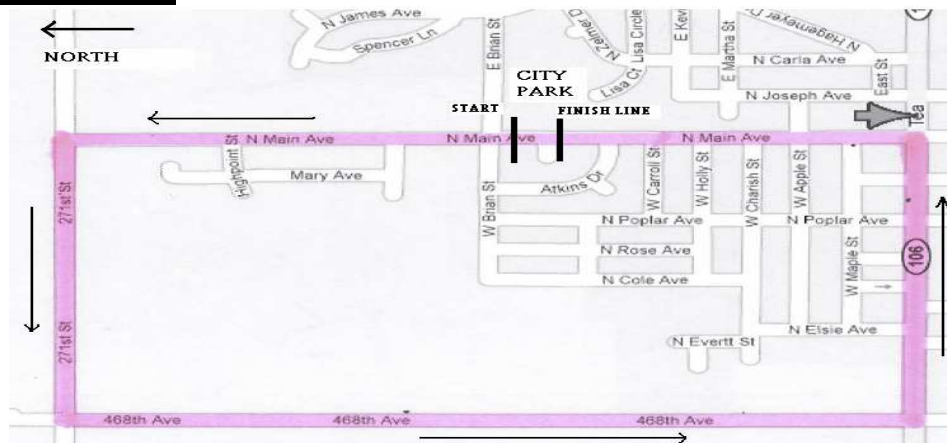

Knowing these facts and in consideration to your accepting my entry, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on my behalf, covenant not to sue, and waive, release and discharge the City of Tea Park & Recreation Board, volunteers; any and all sponsors including their agents, employees, or anyone acting for or on their behalf, from any and all claims or liability for death, personal injury or property damage of any kind or nature whatsoever arising out of, or in the course of, my participation in this event through that liability may arise out of negligence or carelessness on the part of the persons named in this waiver.
